Annual Report of FY 2022 2022 年度 年次報告

(2022年5月1日~2023年4月30日)

2023 年 5 月 8 日に新型コロナが感染症法上で 5 類に変更されたことを受け、長かったコロナ禍もひと段落がつきました。 2022 年 5 月~2023 年 4 月はコロナ禍最後の 1 年となりましたが、大規模なものを含めて対面でのイベントを徐々に再開しながらもオンラインによるプログラムも併存させる形での過渡期的な対応となりました。 100 周年記念事業を含めたイベントの開催総数は 33 と 2021 年度の 28 より増加致しました。

その中でも象徴的なのは、6月にグランドハイアット東京で開催された安倍、エマニュエル両名誉会長を歓迎する会、11月に京都で開催された日米国際シンポジウムで、ともに数百人規模の参加者を得て久々に大規模なリアルイベントの復活となりました。今後は更にリアルイベントの復活を進めコロナ禍前のレベルに活動を活性化させて参りますが、この機会に会員の皆様の日頃からのご支援に感謝し、2022年度の活動実績を報告いたします。

1) プログラムの実施状況

2022 年度に開催したプログラムの詳細は Calendar of Event (P10-14) をご覧ください。

各界から著名なゲストスピーカーをお招きする月例会については、2020年3月まではWhite & Case 法律事務所 殿のご厚意により会場を提供頂いておりましたが、コロナ禍を含め感染リスクが完全に消しきれない昨今に至るまで月例会(5件)は全てオンラインでの開催としております。オンラインでの開催は柔軟な設定が可能となるため、タイムリーに生きた情報を会員間に広く共有できるイベントとして定着してきましたが、今後はWhite & Case 法律事務所殿のご理解を頂戴しつつ、対面イベントとしての復活を目指して行きたいと考えております。尚、いつもながら大井孝理事には同時通訳サービスのご提供を頂いており、この場を借りて厚く御礼申し上げます。

この他、会員間の交流を広める企画として、コロナ禍以前には、総会後の懇親会、米大使館公邸でのパーティー、在日米国商工会議所との共催イベント「飲む・ニケーション」、米軍基地見学会など開催していましたが、昨年度はゴルフ会、AJS サロンなど小規模なイベントの開催に留まりました。今年度は既に米海軍横須賀基地見学を再開しましたが、今後はリアルイベントの取組み範囲を拡大して行きます。

また、100周年記念行事については、柱となる日米若人による英語での討論会 NGRT はほぼ毎月開催され、若人間の入会や相互交流に貢献しております。森ビル殿のご支援に深謝いたします。この他、9月に第4回金子堅太郎賞の授賞式、12月には VSJ プログラムによる米国人研究者の日本招聘をいずれも4年ぶりに開催しました。一方、第3回アメリカボウル大会は、コロナが沈静化しない状況での海外渡航を懸念したとみられる出場校数の減少から止むを得ず中止と致しました。

2) 会員の状況

P-15 の通り、新型感染症の影響で法人会員 1 社(中谷医工計測技術振興財団)が退会、1 社(America School In Japan)が入会となりました。個人会員については、準会員・学生会員が増えた一方で、維持・正会員は微増に留まっています。学生会員は、2020 年から導入した入会時の NGRT プログラム参加費免除、学生会員年会費の値引き(3 千円から 2 千円)によって継続して増加しており、4 年前との比較では約 93%増となっています。また女性の比率も 4 年前より 17%程増加しています。一方で米人の構成比は依然 11%のままです。会員の皆様に個人会員の入会を引続きお願いすると共に、特に米人会員の入会にご支援くださるよう改めてお願い申し上げます。

3) 役員について

当協会の役員(理事・監事)は定款第5章第18条及び第23条により「理事9名以上13名以内(任期2年)、監事2名以内(任期4年)」と定められております。今年度は、理事13名中2名が今総会で任期を迎えますので、今総会の議案として重任の承認をお諮り致します。ご承認頂きますと、今回重任を受けた2名を含めた再任理事は13名、監事は2名となります。尚、今年度に退任する理事・監事はおりません。

名誉会長については、2020 年 11 月に就任された安倍晋三元首相は 2022 年 7 月に不慮の事故によりご逝去されました。また、名誉副会長で金子堅太郎賞選考委員長を務められた斉藤邦彦元駐米大使が 7 月に逝去されました。日米関係の維持発展に尽くされたお二人の業績に改めて深く感謝すると共に衷心より哀悼の意を表します。これらに加え評議員に亀岡エリ子氏に新たに御就任頂きます。全体の就任状況については P8-9 をご覧ください。

4) 財務・経理の状況

収支の状況は、①通常の一般事業と②100周年記念事業に分けて報告します。

- ① 一般事業の状況: P-16 に記述の通り、昨年度の大幅な黒字(10,515 千円)から赤字(△1,284 千円)となりました。昨年度の黒字は 2020 年 12 月に逝去された谷静子評議員の遺贈 10,000 千円に依る一過的なものであり、今年度の赤字は当初計画値(△2,132 千円)に従った上でコスト削減を行った結果を反映しております。赤字となった要因は、主に名誉会長歓迎イベント会場費の負担、事務所貸借料の値上げ等によるものです。尚、本年度より谷静子基金は日米の若人交流促進のために使用を開始させて頂き、主にインターン生による活動に要する交通費、アメリカンスクール(ASIJ)との共同イベントに掛かる費用等にて 2022 年度では 184 千円を費消致した。この場を借りて御報告致します。この他、収入面では若手会員の大きな増加がありましたが、収入増への貢献は限定的です。
- ② 100 周年記念事業の状況: P-17 に記載の通り、会員の皆様より頂戴した「100 周年記念基金」を大切に使用させて頂き4つの記念事業を推進した結果、2022 年度には5,647 千円を費消し期末での残額は75,274 千円となっております。

5) 100 周年事業について

創立 100 周年を記念して頂戴したご寄附は特に日米相互理解と友好促進を進めるため、さらには日米の若人の国際交流を支援するための以下の4つのプログラムに使用してまいりました。2022年度の実績と決算はP-17、2023年度の予算はP-23をご参照ください。

① 日米協会金子堅太郎賞

長年に渡り日米交流に草の根レベルで貢献した一般人を対象とする賞です。選考委員会は、斉藤邦彦元 駐米大使(当協会名誉副会長)のご逝去を受けて、茂木キッコーマン名誉会長を委員長に、委員には、 大橋 ANA ホールディングス相談役、ラフルアー在日米国商工会議所会長(当協会副会長)、ジャーナ リストの国谷裕子氏、久保文明防衛大学校校長、日米協会を代表して小職を委員としています。また今 回の第4回審査より樫山奨学財団 亀岡エリ子理事長に新たに委員に就任頂きました。

尚、授賞式については、2019 年 10 月の第 3 回式典の開催以降、コロナ禍他により中断していましたが、2022 年 9 月に国際文化会館にて開催し、本賞を 2 名、1 団体、特別賞を 2 名に贈呈しました。次回第 5 回の選考は 2024 年の予定です。

② NGRT (Next Generation Roundtable in Tokyo)

次世代向けのプロジェクトの目玉として、コロナ禍にも拘わらず「次世代ラウンドテーブル in TOKYO (NGRT)」を継続的に実施しております。東京でアメリカ人と英語で議論する場を作り、日米両国の若人のネットワーキングを図ることを狙いとするもので、年間を通じ10回程度を六本木ヒルズクラズまたはアークヒルズクラブ(会場ご提供:森ビル殿)にて行い、米人をはじめ企業会員の若手社員や若い個人会員からも多数の参加を得ています。

2022 年 10 月から第 6 期生プログラムを開始し 4 月末までに 6 回実施しています。毎回各界の新進気 鋭のスピーカーをお招きすることで活発な議論が展開されています。2020 年募集の第 4 期生より 40 歳以下の会員への参加を無料とすることで若手の会員増に直結する制度と致し、若人の会員増にも貢献しています。

③ Visit and Study Japan Grant Program (VSJ)

米国の大学院で日本研究を行っている米国人学生の短期日本研究訪問の助成金プログラムです。 別途選抜された米国の大学院生に日米協会から奨学金と外務省からの助成による渡航費を援助します。 2019 年度以降は同プログラムによる渡航ができない状態となっていましたが、2021 年に合格した 1 名が渡航規制の緩和を受けて2022年12月に来日調査を行い、協会事務局で研究発表会を行いました。

④ アメリカボウル大会

アメリカボウル大会は、日本人高校生を対象に、アメリカの歴史・文化・芸術・地理・科学・日米関係などについての知識を簡単な英語で問うクイズ大会です。米国のワシントン DC 日米協会が永年開催しているジャパン・ボウルの経験を活かしてアメリカ人と日本人合わせて 15 名程度の準備委員会を構成し準備を進めましたが、2020 年度、2021 年度ともコロナ禍に於ける緊急事態宣言等で中止となっていました。2022 年度は再開を期して準備を進めましたが、コロナが収束しきっていない環境下での海外渡航を懸念したとみられる出場校数の減少から、止む無く中止と致しました。尚、同大会の名誉総裁には高円宮妃殿下に御就任頂いている他、次の団体から支援を頂いております。助成:米日財団、後援:外務省、アメリカ大使館、全英連、ワシントン DC 日米協会、国際ビジネスコミュニケーション協会、国際教育振興会、日本国際教育協会、港区教育委員会。

本年度も会員の皆様の為の日米協会として活発に活動して参りますので引き続きご理解とご支援をお願い申し上 げます。今後とも都度ご案内いたしますプログラムへのご参加をお待ち申し上げます。

Annual Report FY2022

For the fiscal year ended April 30, 2023

Dear Members of the Society,

In response to the reclassification of Covid-19 by the government as of May 8, 2023, the prolonged pandemic in Japan finally seems to have come to an end. It can be said that the fiscal year of 2023, from May 2022 to April 2023, coincided with the final part of the pandemic. In other words, the year can be remembered as a transitional phase with online programs coexisted with face-to-face events, partly including large-scale ones. The total number of events held during the period, including the centennial projects, reached 33 while that of FY2021 was 28. In particular, the welcome event for Honorary Presidents, Shinzo Abe and Rahm Emmanuel, held at the Grand Hyatt Tokyo in June and the International Symposium held in Kyoto in November epitomized the significant revival of large-scale events with hundreds of attendants. We will further continue to promote the real events at the upcoming year. I would like to take this opportunity to thank you, all the AJS members, for your consistent support of the activities and am delighted to report the results of FY 2022.

Firstly, the following are the summary of our activities in FY2022.

Please see the Calendar of Events (p.10-14) for details on the programs held in last year. Up until March 2020 when the pandemic began, the venue for the monthly meetings inviting famous guest speakers from various fields had been provided by courtesy of White & Case law firm, but under the circumstances where the risk of infection through face-to-face events cannot be completely ruled out, all monthly meetings have been inevitably switched to online. At present, setting up the time of the event flexibly along with the prevalence of online events, it has become widely acknowledged that online events can be easily shared superseding the difference of place and time. However, with the support by White & Case law firm providing us with the opportunities to use their conference room, we would like to seek the opportunity to switch it to real events once again as before pandemic era. Last but not least, we would like to take this opportunity to express our sincere thanks to Dr. Takashi Oi, Director of the AJS, for his support in providing simultaneous interpretation services as always.

In addition, in order to expand networking among the members, we had once held a number of social gatherings before the pandemic: such as the parties after the General Meeting or at the official residence of the U.S. Embassy; "Nomu-Nication" co-hosted with the American Chamber of Commerce in Japan and tours of U.S. military bases. Currently, we are only mainly working on

holding small scale events such as golf competitions, AJS salons, and U.S. base tours, but we will continue to expand the scope and frequency of such events.

In addition, for the centennial events, we are pleased to report that the following events were successfully organized: the 4th Kentaro Kaneko Award ceremony in September; the VSJ program inviting an American researcher to Japan in December for the first time in four years, and NGRT, owing to special support by Mori Building, has been held almost every month continuously. All those programs have been contributing to the increase of participation by young members and thus the revitalization of the Society. The 3rd America Bowl quiz competition scheduled for November was regrettably canceled due to the unexpected decrease in the number of participants, which we presume might be due to their reluctance to see off their students abroad where the pandemic still persisted.

Secondly, regarding the number of AJS members, we had to accept the resignation of one corporate member, while one company, American School in Japan, joined. As for individual members, while the number of student members increased, the number of sustainable, regular, and associate members increased to only limited extent, resulting in slight increases of revenue. On the other hand, the increase in student members is attributed to the program fee waiver measure for those who wish to join NGRT and the reduction of annual student member fees (from 3,000 yen to 2,000 yen) introduced in 2020, which has been contributing to the revitalization of the association's activities through increased participation of younger people, which has reached 193% to compare with that in 2018. And also, the ratio of female has increased by 17% from 2018. Please give your support for new admission of individual members, especially American members, as they still account for only 11% of the total membership.

Thirdly, with regard to the officers of the Society, in accordance with Chapter 5, Article 18 and 23of the articles of association, the number of officers should be at least 9 and up to 13 directors for a term of two years. In addition to the above, there is a maximum of 2 auditors for a term of four years. This year, 2 members of the Board of Directors will be termed out and hence need reappointments at the general meeting. If they are approved, the total number of directors remains 13, including the said reappointed directors, while there remain the presently appointed 2 auditors with no retiring directors and auditors.

As to the Honorary President, Shinzo Abe, who was appointed in November 2020, demised in the devastated incident in July last year. In addition, Ambassador Kunihiko Saito, Honorary Vice President and head of the Kaneko Award Selection Committee, passed away in July. We would like to express our deepest gratitude for both gentlemen, who had been contributing to the development of the exchanges between two countries.

In addition to these, Ms. Eriko Kameoka will be newly appointed as a councilor. Other Honorary Vice Presidents and Advisors will continue to serve as the same as before. Please refer to P8-9.

The fourth theme is about finance and accounting. The details of revenue and expenditure are reported in two categories: the regular general operations and the centennial commemorative operations. The status of income and expenditures is reported separately for (1) the regular general operations and (2) the centennial anniversary projects.

(1) Status of the regular general operations:

As described on P-16, there was a deficit of 1,284 thousand yen comparing with huge surplus (10,515 thousand yen) in the previous year. The surplus was merely tentative due to the bequest of 10,000 thousand yen from the Ms. Shizuko Tani, who passed away in December 2020. The deficit of this year is just as planned at the outset of the fiscal year. The main reasons are the cost burden of the event inviting the honorary presidents and the increase of the office rent. As to the Shizuko Tani Fund, we have used this fund effectively for the promotion of the exchanges between young people in Japan and the United States and thus consumed 184 thousand yen with the transportation fee of our intern students and the event in collaboration with American School in Japan (ASIJ) in FY2022.

In addition, we have seen a number of increases by the student members, but the contribution to the revenue is limited.

As described on page 17, we have also deliberately used the "Centennial Fund" received from our members to promote four commemorative projects, and as a result, 5,647 thousand yen was expended in FY2022, leaving a balance of 75,274 thousand yen at the end of the term.

(2) The Centennial Donations have been used for the following four programs to promote mutual understanding and friendship between Japan and the U.S., and to support international exchange between young people of both countries. Please refer to P-17 for FY2022 results and accounts and P-23 for FY2023 budget.

i) The Kaneko Award

The Kaneko Award is given to an individual who has made a grassroots contribution to the U.S.-Japan relations. The head of the selection committee was succeeded by Mr. Yuzaburo Mogi, Honorary Chairman of Kikkoman, following the demise of Ambassador Saito, and consequently the committee consists of Mr. Yoji Ohashi, Senior Advisor of ANA Holdings, Mr. Christopher LaFleur of the American Chamber of Commerce in Japan (Vice President of the AJS), journalist Ms. Hiroko Kuniya, Dr. Fumiaki Kubo, President of the National Defense Academy and myself. At the 4th award selection, Ms. Eriko Kameoka, Chairperson of Board, Kashiyama Scholarship Foundation, joined the committee as a new committee member. We have successfully resumed the project and awarded two individuals and one organization as well as special awards to two

individuals at the International House in September for the first time since October 2019, after temporarily suspending the selection in FY2020 and FY2021 to consider the impact of the pandemic. The selection of the 5th Kaneko Award is scheduled to take place in FY2024.

ii) NGRT (Next Generation Roundtable in Tokyo)

NGRT is the centerpiece of the project for the next generation. The original idea was to create a forum in Tokyo for discussion with Americans in English, and the NGRT aims to promote networking between young Americans and Japanese through the series of session. The NGRT is held approximately 10 times throughout the year at Roppongi Hills Clubs and Ark Hill's Clubs, the venues benevolently provided by Mori Building, and has been well attended by both Americans, young individual members and young employees of corporate members.

Starting in October 2022 last year, the six sessions have been already held until the end of April as the 6th program. As the sessions are separately held in small groups, they could be held in person along with up-and-coming speakers invited from various fields. We should note that we have exempted the admission fee for any AJS member since the fourth program, which has directly increased the number of Associate and Student members.

iii) Visit and Study Japan Grant Program (VSJ)

The Visit and Study Japan Grant Program (VSJ) provides grants for short-term study visits to Japan by U.S. students pursuing Japanese studies at U.S. graduate schools in collaboration with MOFA. Although the program itself has been suspended due to Covid-19 since 2020, but two students applied and were accepted in 2021. While one of them declined later, the other applicant completed the research ending up with the session at the AJS office in December 2022. iv) America Bowl

The America Bowl is a quiz competition for Japanese high school students to test their knowledge of American history, culture, art, geography, science, and Japan-U.S. relations in simple English. The Japan-America Society of Washington, D.C., in the U.S. has long held the Japan Bowl, and a preparatory committee of about 15 American and Japanese members was formed to prepare for the event. However, due to the Covid-19 related concerns, the events have been forced to be cancelled since the pandemic began.

It is an honor that Princess Takamado agrees to assume the Honorary President of the event.

And the event is also supported by: U.S.-Japan Foundation, Ministry of Foreign Affairs of Japan,
U.S. Embassy, ZEN-Eiren, Japan-America Society of Washington DC, the Institute for
International Business Communication, Association for the Promotion of International Education,

We will further pursue effective activities for our members. We look forward to your continued understanding and support.
